Acceptance of Preliminary Budget for 2013: Miliotto presented the current proposed draft budget for 2013 highlighting some of the adjustments made in the forecasting of both revenue and expenses.

12:45 **Brighton Resolution**

Bishop Gibbs

Diocesan Council members Deon Johnson (Rector, St. Paul's Brighton) and Jenny Ritter (member, St. Paul's Brighton) were asked to excuse themselves from the room so that a conversation regarding a resolution for St. Paul's could be engaged. Bishop Gibbs presented demographic information and material supporting a resolution requesting monies for a significant renovation project for St. Paul's, Brighton. The details of the resolution include:

Resolved, that the Executive Council of the Episcopal Diocese of Michigan, meeting at All Saints' Episcopal Church, East Lansing, MI on June 23, 2012, authorizes financial support of the building project at St. Paul's Episcopal Church, Brighton, MI with a combination of loans and grants in the total amount of \$600,000.00 over a period of three years; *and be it further*

Resolved, that \$300,000 of the financial support is made in the form of grants from any of the following three funds: Centennial Fund, the Reinforcement Fund and the Endowment Fund; such disbursements to be managed by the Director of Finance; *and be it further*

Resolved, that \$300,000 of the financial support is made in the form of a loan from the Bishop's Building Fund, with the following stipulations:

- a) No repayment is required or expected for the first 3 years of the loan
- b) There is no interest on the loan

- c) During the first 3 years of the loan, St. Paul's agrees to maintain its full assessment to the Episcopal Diocese of Michigan, submit its parochial report according to canonical requirements, and submit its annual audit report by the due date
- d) If St. Paul's fully complies with item (c), the \$300,000 loan from the Bishop's Building Fund will be forgiven.

The terms of the combination grant and loan were explained and a motion was made and properly seconded. Motion passed (with 2 abstentions).
