Role of Diocesan Council Members:

Definition of Fiduciary (Bishop Gibbs passed this out to all of us)

What is a "Fiduciary"?

Essentially, a fiduciary is a person or organization that owes to another the duties of good faith and trust. The highest legal duty of one party to another, it also involves being bound ethically to act in the other's best interests. A fiduciary might be responsible for general well-being but it often involves finances. — managing the assets of another person, or of a group of people, for example. Money managers, bankers, accountants, executors, board members, and corporate officers can all be considered fiduciaries.

Responsibilities of a "Fiduciary"

A fiduciary's responsibilities or duties are both ethical and legal. When a party knowingly accepts a fiduciary duty on behalf of another party, he or she is required to act in the best interest of the principal, the party whose assets they are managing. The fiduciary is expected to manage the assets for the benefit of the other person rather than for his or her own profit, and cannot benefit personally from their management of assets. This is what is known as a prudent person standard of care, a standard that

originally stems from an 1830 court ruling. This formulation of the prudent-person rule required that a person acting as fiduciary was required to act first and foremost with the needs of beneficiaries in mind.

Term Limits – Two successive three-year terms; those who replace another member finish that term and are entitled to two full terms of their own; must take a year off after two three-year terms. As a result, one third of Council members are new each year. Some members are elected and some are appointed.

Loans and Grants

1. Request to reduce the loan amount outstanding for St. Matthew and St. Joseph's, Detroit: The Loans and Grants Committee has reviewed the history of the 1999 diocesan council loan in the amount of \$150,000 to St. Matthew/St. Joseph's, Detroit. Given the circumstances outlined in the history and the current realities of the congregation, the Loans and Grants Committee moves the following: That the outstanding loan balance for St. Matthew & St. Joseph's, Detroit be reduced from \$82,037.67 to \$24,612 (as of July 2016). The amount of the loan forgiveness requested is 57,425.67. (Note: Payments of 1,200 have been made since July 2016.)

Additionally: The leadership will be advised that monthly payments of at least \$300 are to continue, and that there will be no further reduction of the loan amount. The congregation will also be commended to the Vital Congregations Committee and Canon Jim Gettel for follow up regarding direction and redevelopment. *Motion passed, with one abstention.*

2. Request to Approve Covenant 5 Grants: The Covenant 5 group met and has made recommendations for disbursement of the 19,000 of grant monies allocated in the diocesan council operating budget. Additionally, they have allocated 1,000 of unused grant money from last year, making the total for

disbursement \$20,000. The Loans and Grants Committee has reviewed the information provided by Covenant 5, and moves the allocations listed below. *Motion passed*.

A motion was made and properly seconded to approve this resolution. Motion passed.

Whereas the Reverend Juan Perez is employed as a minister of the Gospel of the Episcopal of the Episcopal Diocese of Michigan, which does not provide a residence for him, the Diocesan Council resolves that, of the total salary of \$54,661 to be paid to Rev. Perez during 2017, \$15,000 be designated as parsonage allowance within the meaning of that term as used in Section 107 of the IRS Code of 1986. A motion was made and properly seconded to approve this resolution. Motion passed.
