• Safeguarding Model Policies Task Group Update/Q&A with Eric Travis and Vicki Hesse Model Policies are the minimum of what we will do in our diocese (e.g. renew every 3 years, not 5); Universal Training is for everyone in the church, children on up—our diocese has created 1.5hour training as a part of spiritual formation that anyone can offer anywhere—AND some need more training and our diocese has created one extra 6-hour training for leaders and supervisors In June, there will be 3 train-the-trainer sessions

Property Report

Canon Hardy presented a written report.

1. Property of St. Peter's, Tecumseh—Congregation leasing property to merge with another church. Request for permission to evaluate property, and list for sale, with assistance of diocesan realtor. Motion made and properly seconded. *Motion passed*.

2. Property of Emmanuel, Detroit—Buyer has requested extension of 3 years on land contract. Interest rate 4%. Motion made and properly seconded. *Motion passed*.

3. Property of St. Matthew's Flat Rock—Buyer has requested that 4 months (April, May, June, and July 2018) of land contract payments be added to the end of their contract. Payments to resume for August 2018. Motion made and properly seconded. *Motion passed*.

Financial Report

Mark Miliotto presented a written report. A motion was made and properly seconded to receive the Treasurer's report and file for audit. *Motion passed*.

Updates/Committee Reports

Primary Committees

Mission Budget – Mark Miliotto presented a report. First budget hearing at St. Paul's Lansing on May 5th during Ministry Fair. Next hearing is at the Cathedral May 24th at 7:00 pm. Will present draft budget at next Council meeting.

Tithes & Offerings – Mark Miliotto presented a report. \$23,000 allowance in budget for shortfalls. Already approved reductions totaling more than that. Other congregations trending towards not making full pledge. Trinity Farmington Hills trending ahead.

Loans and Grants – Jo Ann Hardy presented a report.

Bricks and Mortar Grants:

The amount available in the fund for distribution this month is 8,892 with an additional 10,869 to become available on June 30^{th} . The Committee received 2 applications for consideration.

1. St. George's, Milford--Has requested \$10,000 grant to help fund an emergency boiler update that was done on Good Friday. They had used funds that were from a capital improvement fund intended for necessary roof repair. The committee has limited amount of funds and is not able to fund the full request but recommends approval of a grant of \$4,400. (Congregation can also apply to the Trustees for a grant for this project). *Motion passed*.

2. Resurrection, Ecorse--Has requested \$25,630 to fund replacement of their sewer pipes includes replacing pipes, pumps, electric panels and motors. The congregation is asking us to fully fund the project which we don't have the resources to do. The committee recommends approval of a grant of \$4,400 which we will hold in reserve until we see they have enough money to finish the project. (Congregation can also apply to the Trustees for a grant for this project). *Motion passed*.

The committee recommends that we hold the June disbursement for emergency needs as they arise over the summer.

Bricks and Mortar Loans:

The Committee received two requests for loans. The committee recommends the loans for Milford and Livonia with details of funding source, terms and interest rate will be determined by the Director of Finance and the Canon Administrator.

1. St. George's, Milford has asked for a 10-year loan for up to \$30,000 to fund their roof repair. They have been active in raising money for capital projects and this is the third necessary major capital project done within two years. *Motion passed*.

2. St. Andrew's, Livonia has requested an additional \$10,000 loan to complete their parking lot project. A previous loan of \$25,000 was awarded in June 2017. *Motion passed*.

Vital Congregations – Clare Hickman presented a report. They haven't been sent anywhere. They will communicate with Jim Gettel to see how they can assist with any congregations having difficulties. Will start planning advanced renaissance workshop planning for the fall.

Emrich Presentation – Fr. Deon Johnson

About 3% of retreat centers in U.S. are self-sustaining. Plans for moving ahead:

- Reduce capacity from 91 to 75 (removing bunk beds)
- Changing website—online registration, virtual tour, etc.
- New marketing plan—e.g. confirmation retreat with YAYA, market to other local churches
- New brochure
- Invite congregations to sponsor a room renovation
- Sponsoring retreats offered to diocese and local community, renting meeting spaces
- Boosting wireless service

The diocese may need to help financially to keep Emrich afloat.

Resolution Review – Judith Schellhammer presented a written report.
