CURACY FUNDING CHANGES: GOALS AND INTENTIONS

- Transparency for curacy funding process
- To align with our goals as a diocese "to create, form, and nurture leaders"
- Encourage a culture of learning and forming leaders in all of our congregations

FOUR FUNDING OPTIONS FOR SEMINARIANS, CURATES AND NEWLY ORDAINED OPTION I

\$5000 For a
Summer Internship
(Seminarian)

- Churches can apply to provide a seminarian with Field Ed intensive over a summer
- Expectations include regular meetings with the rector/priest-in-charge, full involvement in the life of the congregations, and an evaluation written by the rector

FOUR FUNDING OPTIONS FOR SEMINARIANS, CURATES AND NEWLY ORDAINED OPTION 2

Funding for hiring a newly ordained person as vicar, rector, priest-in-charge

- Congregations may apply for funding (asking for up to ½ of the cost)
- Funding would be stepped down over the three years

FOUR FUNDING OPTIONS FOR SEMINARIANS, CURATES AND NEWLY ORDAINED OPTION 3

Funding for congregations hiring a newly ordained person in order to grow the ministry of the church

- Congregations may apply for funding (usually asking for ½ of the cost)
- Funding would be stepped down over the three years

FOUR FUNDING OPTIONS FOR SEMINARIANS, CURATES AND NEWLY ORDAINED OPTION 4

Funding for

"Teaching
Congregations" that
apply and are
chosen to mentor
curates.

- This is for congregations that discern a specific call to train, teach and form curates
- Congregations may apply and be granted curacy funding for 3 years, which may be renewed.
 (Congregations may ask for up to ½ of the cost).
- Congregations must interview candidates from the Diocese of Michigan, but may hire from any diocese in the Episcopal Church

OUR TEACHING CONGREGATIONAL MODEL



- This model is for every church, no matter the size, location, or condition
- This model is based on Kennon
 Callahan's "I 2 Keys to an Effective
 Church" and they are the relational
 aspects of that model
- The invitation is to focus on relational development




