Dear Growth and Income Fund Investor:

We had another decent quarter in the Growth and Income Fund with the net investment performance for the second quarter coming in at 4.20%. The benchmark for the quarter was 3.99%. We now have had three straight quarters of positive returns, this preceded by three straight quarters of negative returns. With all that up and down, the net investment return for the past 12 months is now at 10.90%, which is slightly higher than the benchmark return of 10.80%.

Domestic stocks led the way this quarter, with our two domestic stock funds each ending the quarter up in the range of 8-9%. International stocks and our REIT fund posted modest gains while our bond funds were mixed. Since inception with our current investment advisor (June 2014), the net investment performance has averaged 6.10% per year while the benchmark has been 5.98%.

The share value of the Fund as of the end of the second quarter was \$34.2967, a 3.2% increase over the first quarter value of \$33.2410. Over the last twelve months, investment management fees have been 0.10%, accounting/audit fees were 0.06% combined, and dividend payouts to investors have averaged 3.92% (of the average asset value).

The Q2 2023 dividend of \$0.3299 per share will be distributed in late September. Your dollar payout is identified in the lower right corner of your Balance and Activity Report (which was emailed to you on August 2). The dividend rate for 2024 will be set by the Trustees of the Diocese in mid-September. I will inform you of their decision shortly after that meeting.

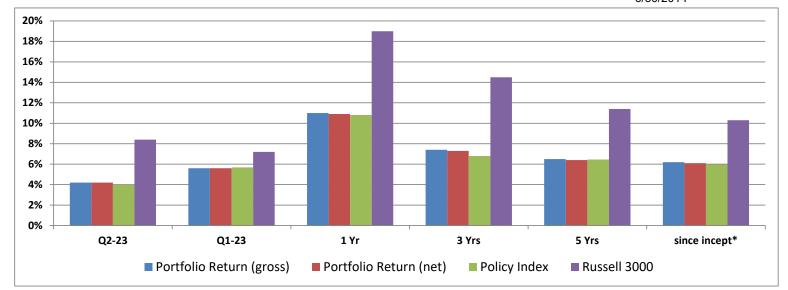
