Bishop Perry's Update

Bishop Perry discussed the overnight youth event at the Cathedral (30+ participants from 7 congregations), a workshop presented by the Legacy Giving Committee, and her involvement with efforts to pass sensible gun laws. Dates for upcoming events were reviewed.

Review of Financial Reports - Jo Ann Hardy

Canon Hardy reviewed the current year to date financials and the final recap on the 2022 financials, in Canon Miliotto's absence. Motions to receive these reports and file for audit were made and seconded. Motions passed.

Social Service Ministries Grants:

The Loans and Grants Committee recommends that the 21 Social Service Ministries grants be allocated as requested in the amount of \$62,830. The Loans and Grants Committee also requests that \$9,330 from the Sustainable Development Fund be used to help fund these grants (\$53,500 from the diocesan budget; \$9,330 from Sustainable Development Fund. Special Loan Request from the Cathedral Chapter/Cathedral Church of St. Paul: The Cathedral Chapter, the entity that runs the 4800 Woodward complex, is in a cash deficit, and is requesting a loan of \$100,000. The committee reviewed the information provided by the Dean of the Cathedral, as well as the 2021 audit of the Cathedral and the Cathedral Chapter.
