Ratification of Executive Committee Actions: Bishop Perry & Mark Miliotto

1) On December 17, 2022, the Executive Committee of Diocesan Council unanimously approved a loan for Church of the Incarnation, Ann Arbor, as follows:

Be it resolved:

That the Diocesan Council extend a loan in the amount of \$150,000 to Church of the Incarnation, Ann Arbor, to assist with financial needs as recovery efforts take place following an embezzlement of funds. Final terms of the loan will be negotiated after the results of the recovery effort have become clear. This action was ratified, with Jamie Taylor abstaining.

2) On December 6, 2022, the Executive Committee of Diocesan Council affirmed the Standing Committee's recommendation for a 4% COLA adjustment for the bishop.

Be it resolved:

That the Diocesan Council affirm the Standing Committee's recommendation for a COLA increase in the amount of 4%* for the Rt. Rev. Dr. Bonnie A. Perry, effective January 1, 2023; and that the increase includes any adjustments necessary to reflect changes in pension contribution.

This action was ratified.
