#### Dear Growth and Income Fund Investor:

Early in the third quarter of 2023, equity markets continued their upward trend as they had for the previous three quarters. But then things softened starting in August and continued through September. Overall, the Growth and Income Fund investment performance was down 3.0% for the quarter. All of our funds were in negative territory except our short-term bonds which eked out a very small gain. Year-to-date, however, we are up 6.7% and for the past 12 months we are up 14.1%. Compared to our benchmark we slightly outperformed the Q3 target of 3.48% as well as the year-to-date target of 6.08% and the 1-year target of 13.66%.

Over the longer term, we have averaged an annual net investment return of 5.6% while the benchmark over that timeframe is 5.41%.

The share value of the Fund as of the end of the third quarter was \$32.9381, which was a 3.96% decrease from the second quarter value of \$34.2967. Over the last twelve months, the share value is up 9.7% while investment management fees have been 0.10%, accounting/audit fees were 0.07% combined, and dividend payouts to investors have averaged 3.97% (of the average asset value).

The Q3 2023 dividend of \$0.3299 per share will be distributed around Christmastime. Your dollar payout is identified in the lower right corner of your Balance and Activity Report. The dividend rate for 2024 was approved by the Trustees of the Diocese in September. The payout will be \$0.3423 per share per quarter – a 3.8% increase over the 2023 dividend payout.


