Emrich Center Update – Jo Ann Hardy

On January 16, 2024, a letter went out announcing the cessation of operations at Emrich. In 2022 a group convened to consider Emrich's situation and found that, since COVID, camps and retreat centers throughout the Church have seen a decline in operations. A committee is forming to consider the future of Emrich.

Review of Financial Reports - Mark Miliotto

A motion was made (Maryjane Peck) and properly seconded (Diana Walworth) to accept the financial reports and file for audit. Motion passed.

# 2022 Audit Review - Mark Miliotto/Michele Wogaman

It was a clean audit with all matters from the prior year resolved. Luke Thompson moved to accept the audit, and Maryjane Peck seconded. Motion passed.

## Property Updates – Jo Ann Hardy

- Resurrection, Ecorse A neighboring business wants to rezone the area and will need occasional use of five parking places. Karen Lewis moved to enter into a pro bono agreement for use of parking spaces at the church, and Maryjane Peck seconded. Motion passed.
- St. Elizabeth's, Redford and Christ the King, Taylor -- Both of these congregations closed 1 ½ years
  ago and both properties have been leased to other church congregations. The tenants in both cases
  want to enter into land contracts for purchase of these properties. Karen Lewis moved that we enter
  into negotiations with these tenants for possible land contracts. Michele Wogaman seconded. Motion
  passed.

# Discussion of Human Resources Policy – Jo Ann Hardy

- Paid Parental Leave Data Gathering Group Currently, birth parents are eligible for paid parental leave but non-birth/adoptive parents are not. A group is forming to explore the policies of other dioceses.
- Employee Assistance Program All congregations are encouraged to provide this coverage (\$4.00./month per employee) for all employees regardless of number of hours worked. This program provides options for mental health care.

#### Loans & Grants Committee Report – Emily Williams Guffey

- Bricks & Mortar Request St. Aidan's, Ann Arbor Karen Lewis moved to provide a grant for \$10,000 for parking lot resurfacing: no second required. Motion passed.
- Update on Social Service and Advocacy/Public Witness Grants Congregations are encouraged to apply for these Public Witness Grants.
